The first item on the agenda is a public hearing on ordinance amending Chapter 3, Section 2 of the Code of Ordinances of the City of Sulphur – Sale on Sunday (alcohol). Motion was made by Mr. Moss seconded by Mr. Favre that the following ordinance be adopted to-wit:

## ORDINANCE NO. 1364, M-C SERIES

ORDINANCE AMENDING CHAPTER 3, SECTION 2 OF THE CODE OF ORDINANCES OF THE CITY OF SULPHUR, LOUISIANA – SALE ON SUNDAY.

WHEREAS, an election was held on November 21, 2015 for the following proposition which was approved by the voters of the City of Sulphur, Louisiana:

## **PROPOSITION**

Shall the City of Sulphur, Louisiana (the "City") permit retail sales, serving and dispensing of alcoholic beverages, by holders of any permitted class for alcohol sales, on Sundays beginning at 12:00 noon, within the City, by amending Article I, Chapter 3, Section 3-2(a and b) of the Code of Ordinances of the City, to provide therefor?

WHEREAS, with 2,281 votes in favor of said Proposition, Ordinance No. 278, M-C Series was repealed.

BE IT ORDAINED by the City Council of the City of Sulphur, Louisiana, the governing authority thereof, that they do hereby amend Chapter 3, Section 2 of the Code of Ordinances of the City of Sulphur, Louisiana to read as follows:

## Sec. 3-2. – Sale on Sunday.

- Alcoholic beverages of either high or low alcoholic content may be sold (a) at retail within the corporate limits of the city, from midnight Saturday night until 1:30 a.m. on Sunday morning, after which no further alcoholic beverages may be sold and the retail place of business must be closed and all occupants must have vacated the premises thirty (30) minutes thereafter, i.e., by 2:00 a.m.
- No alcoholic beverages shall be given, traded, bartered, sold, or delivered (b) between the hours of 1:30 a.m. and 11:59 a.m. on Sunday mornings.

BE IT FURTHER ORDAINED that this ordinance shall become effective upon Mayor's signature.
