The City Council of the City of Sulphur, Louisiana, met in regular session at its regular meeting place in the Council Chambers, Sulphur, Louisiana, on December 12, 2016 at 5:30 p.m., after full compliance with the convening of said meeting with the following members present:

After the meeting was called to order and the roll called with the above result, prayer was led by Ed Holmes, followed by the reciting of the Pledge of Allegiance led by Mr. Favre.

The Chairman asked if there were any changes to the minutes of the previous meeting. With no changes made, motion was made by Mr. Moss seconded by Mrs. Hardy that the minutes stand as written. Motion carried.

The next item on the agenda is a presentation by Armed Forces Committee. The Committee presented a certificate to Charles Rutherford and thanked him for his years of service to our country.

The next item on the agenda is Sara Judson, President/CEO of Community Foundation Southwest Louisiana, to speak on Workforce Scholarship Fund. Ms. Judson could not attend the meeting so Kim, Public Affairs for Sasol attended. She gave a brief presentation (see attached) and stated that they're giving out scholarships. They need approximately 60 applicants and so for they've only received 6. She asked that everyone spread the word that they need more applications turned in.

The next item on the agenda is a public hearing on ordinance granting a rezone from Residential to Commercial for Dr. Charles Smith for property located east of Beglis Parkway, north

of I-10 and south of Linda Avenue to promote commercial development. (*To hear complete discussion log onto www.sulphur.org and view City Council meeting December 12, 2016*). Mr. Sonnier, resident, asked that this item be tabled until flooding mitigation is complete.

Ms. Ramirez, resident, stated that she reviewed 2 zoning maps and on both maps this property is zoned Residential. We've submitted 76 signatures opposing this rezone. She asked that no windows be placed on the north side to give neighbors privacy.

Matt Redd, representing property owner, stated that the property is under contract. They plan on developing a hotels/restaurant. They will go through the permit process first. This development should fix the drainage problem in this area.

Mr. Bergeron stated that a drainage study will have to be done prior to construction. If the Developer were to put residential living in this area he couldn't afford it since he'd have to build up the property so much. City should be able to sit with the developer to make sure drainage is done correct and he plans on doing that. Gravity Drainage will also be required to approve drainage as well as internal approvals by administration.

Mr. Moss stated that there's a lot of wet area on this property and it'll probably take a whole lot of money for drainage.

Mr. Atherton asked how the heavy truck traffic will be managed through the neighborhood. Mayor Duncan stated that heavy trucks will not be able to go through the neighborhood. They can only access the property off Beglis Parkway.

Mr. Redd stated that with regulations put in place it'll have to drain the correct way. He also stated that he sent the residents a letter with stipulations and asked that Council amend the ordinance to allow for these stipulations.

At this time motion was made by Mr. Favre seconded by Mr. Moss that the ordinance be amended to allow for the following stipulations:

- 1. Establish a 20' buffer on the property line where no trees can be cut and no underbrush can be cleaned out.
- 2. Install a 6' wood privacy fence on the development side of the property. Owner will be responsible for maintenance of fence.
- 3. Require that any parking for development be required to be placed along the northern portion of the subject property.

ORDINANCE NO. 1433, M-C SERIES AS AMENDED

ORDINANCE GRANTING A REZONE TO DR. CHARLES SMITH FROM RESIDENTIAL DISTRICT TO COMMERCIAL DISTRICT FOR PROPERTY LOCATED EAST OF BEGLIS PARKWAY, NORTH OF I-10 AND SOUTH OF LINDA AVENUE.

WHEREAS, Dr. Charles Smith has submitted application to Rezone from Residential District to Commercial District for property located east of Beglis Parkway, north of I-10 and south of Linda Avenue; and

WHEREAS, the following stipulations shall be placed on property:

1. Establish a 20' buffer on the property line where no trees can be cut and no underbrush can be cleaned out.

- 2. Install a 6' wood privacy fence on the development side of the property. Owner will be responsible for maintenance of fence.
- 3. Require that any parking for development be required to be placed along the northern portion of the subject property.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SULPHUR, LOUISIANA, IN REGULAR SESSION CONVENED THAT:

The Land Use Ordinance of the City of Sulphur is hereby amended to grant a Rezone to Dr. Charles Smith from Residential District to Commercial District for property located east of Beglis Parkway, north of I-10 and south of Linda Avenue for the following described property to wit:

N ½ W ½ NE SE 2.10.10 (T-2)

This Rezone is granted by the City of Sulphur and may be withdrawn by the City of Sulphur should said Rezone interfere with the rights and privileges owned by the City of Sulphur pursuant to a pre-existing right of way, servitude or easement. If withdrawn, any improvements constructed thereon shall be removed at the expenses of owner thereof.

Grantee hereby agrees and contracts to hold Grantor harmless from any damages created and/or caused by the granting of this Rezone, including, but not limited to, litigation defense, litigation costs, violation of subdivision restrictive covenants, building code violations or any other damages, property and/or monetary or otherwise, relating thereto.

The owner of this rezone shall be responsible for the recordation thereof, with the Clerk of Court, Calcasieu Parish, Louisiana, and shall provide the City of Sulphur a receipt evidencing recordation within 10 days of the effective date of this re-zone.

No work shall commence until all applicable permits are obtained. In the event work is commenced prior to obtaining all applicable permits, this Rezone shall be withdrawn and considered null and void.

This ordinance shall become effective upon Mayor's signature.

At this time motion was made by Mr. Favre seconded by Mr. Moss to reconvene to item #5 on the agenda. Motion carried.

After much discussion, motion was made by Mr. Moss to amend 5% to 0%; he then withdrew his motion again. Motion was then made by Mrs. Ellender seconded by Mr. Moss to amend the ordinance as follows:

Motion carried.

Motion was then made by Mr. Favre seconded by Mrs. Hardy that the following ordinance be adopted to-wit:

ORDINANCE NO. 1434, M-C SERIES AS AMENDED

AN ORDINANCE SETTING THE FRANCHISE FEE TO BE PAID BY THOSE ENTITIES PROVIDING CABLE OR VIDEO SERVICE WITHIN THE CITY OF SULPHUR, LOUISIANA MUNICIPAL LIMITS UNDER A STATE-GRANTED FRANCHISE AUTHORITY AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, pursuant to the provisions of the Consumer Choice for Television Act of 2008, codified at LSA-R.S. 45:1361 et seq, any person or entity desiring to provide cable or video services within the City of Sulphur may do so by obtaining a state -issued certificate of franchise authority; and

WHEREAS, pursuant to the provisions of LSA-R.S. 45:1366, the holder of a state-issued certificate of franchise authority for cable or video service is required to pay a franchise fee to a municipality in which it operates upon the passage of an ordinance by municipality setting such a fee; and

WHEREAS, there are persons or entities which operate or desire to operate cable or video services within the City of Sulphur municipal limits.

BE IT THEREFORE ORDAINED by the City Council of the City of Sulphur, Louisiana, the governing authority thereof, that all persons or entities providing cable or video services to the citizens of the City of Sulphur pursuant to a state-issued certificate of franchise authority as provided in LSA-R.S. 45:1361 et seq shall, pursuant to the provisions of LSA-R.S. 45:1366, pay the City of Sulphur a franchise fee equal to three percent (3%) of the cable or video service provider's gross revenues, as that term is defined by the "Consumer Choice for Television Act of 2008," derived from operations within the City of Sulphur municipal limits.

BE IT ALSO FURTHER ORDAINED that all ordinances and resolutions in conflict herewith are hereby repealed, except those approving any cable or video franchise agreement in force and effect between the City of Sulphur and any cable or video service provider.

BE IT ALSO FURTHER ORDAINED that Mayor Christopher L. Duncan is hereby authorized to execute all documents in connection therewith.

BE IT ALSO FURTHER ORDAINED that this Ordinance shall become effective upon the Mayor's signature.
