The next item on the agenda is an ordinance declaring a public emergency necessitating the temporary closure of living quarters and allowing that a travel trailer temporarily be placed at Central Fire Station located at 602 North Huntington Street and also authorizing a lease agreement for fire truck storage and living quarters for firemen. Mayor Duncan stated that on February 8, 2017 they received a mold report stating that there was mold in the fire station. This affects life and safety for employees. The firemen that sleep in this building will need an RV to live in temporarily. The RV will be temporarily placed at this site. Everyone is out of the building and we're proceeding with plans. Motion was then made by Mrs. Hardy seconded by Mrs. Ellender that the ordinance below be declared a public emergency:

An Ordinance declaring a Public Emergency necessitating the temporary closure of living quarters and allowing that a travel trailer temporarily be placed at Central Fire Station located at 602 N. Huntington St., Sulphur, Louisiana. In addition, a lease agreement for fire truck storage and living quarters shall be authorized by the Mayor and City Council

BE IT ORDAINED by the City Council of the City of Sulphur, Louisiana, the governing authority thereof, that based on the recommendation of the Fire Chief Chief Building Inspector, a Public Emergency is hereby declared in the City of Sulphur, Louisiana, due to the need to provide fire protection for life, health, property and public safety; and

BE IT FURTHER ORDAINED that Mayor Christopher L. Duncan is hereby authorized to necessitate the temporary closure of living quarters and allowing that a travel trailer temporarily be placed at Central Fire Station located at 602 N. Huntington St., Sulphur, Louisiana. In addition, a lease agreement for fire truck storage and living quarters shall be authorized by the Mayor and City Council.

BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon adoption.
