- 2. In the last 10 years it has funded over \$32 million on capital projects.
 - a. Over \$5 million on street overlays and rehab.
 - b. Over \$6 million in bridge replacements.
 - c. Over \$3 million on Parish Road reconstruction.

d. Over \$3 million on Logan Street reconstruction.

e. Over \$5 million on waterline upgrades.

f. Over \$7 million on wastewater lift station improvements.

g. Over \$5 million on waterline upgrades and improvements.

h. Over \$1.5 million on Water Plant upgrades and improvements.

3. The funds have helped to improve 33 streets and bridge projects and 48 water and wastewater projects. Over 42% of all capital projects are funded through

these tax proceeds.
