





Maplewood Park Place Management, LLC, a Louisiana limited liability company whose address for the purposes hereof is: _____, appearing herein through its duly authorized undersigned representatives; and **Maplewood Park Place, LLC**, a Louisiana limited liability company whose address for the purposes hereof is: _____, appearing herein through its duly authorized undersigned representatives (hereinafter referred to together as “MPP”); and

THE CITY OF SULPHUR, a municipal corporation and political subdivision of the State of Louisiana (hereinafter referred to as the “City”), herein represented by its duly authorized Mayor, Michael Danahay;

who being duly sworn did declare that:

1. MPP and the City previously entered into a Road Development Agreement related to improvements to Arvel Loop, in the area specified on the attached exhibit thereto, with the aforesaid agreement recorded in Calcasieu Conveyance Book 4287 commencing at Page 101 (the “RDA” and with the road improvements hereinafter referred to as “Arvel Loop”).
2. MPP does hereby irrevocably and permanently donate and deliver unto the City the ownership of the improvements made by MPP to Arvel Loop, and MPP does hereby confirm the City’s perpetual servitude over Arvel Loop for all public purposes, including streets, roads, sidewalks, and utility purposes.
3. City does hereby accept Arvel Loop for City maintenance, provided that the warranty of MPP and/or its contractor pursuant to the RDA shall remain in effect for two years, as specified in the RDA, and the City is additionally assigned any rights of MPP against its contractor for enforcement of the warranty.

AN ORDINANCE ADOPTING THE ANNUAL BUDGET OF REVENUES AND EXPENDITURES FOR THE FISCAL YEAR JULY 1, 2020 TO JUNE 30, 2021, FOR THE CITY OF SULPHUR, LOUISIANA.

BE IT HEREBY ORDAINED by the City Council, City of Sulphur, Louisiana, in general session convened, that:

SECTION I. The attached estimate of revenues as reflected in the summary and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Government Act, be and the same, is hereby adopted to serve as the Budget of Revenues for the City of Sulphur for fiscal year July 1, 2020, to June 30, 2021.

SECTION II. The attached statement of anticipated expenditures as reflected in the summary and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Government Act, be and the same is hereby adopted to serve as the Budget of Expenditures for the City of Sulphur for the fiscal year July 1, 2020, to June 30, 2021.

SECTION III. The adoption of the Budget of Expenditures as reflected in the line-item budget filed with the Clerk of the Council containing object of expenditure classifications shall be declared to be the appropriation of the amount set therein as established in each budget classification by object of expenditure.

SECTION IV. The adoption of the Capital Improvement Budget as submitted for a period of five years with the first year being for the budget year 2020-2021 shall be for the expenditures as appropriated therein.

SECTION V. The amounts appropriated for all accounts shall not exceed the amounts fixed therefor in the Budget of Expenditures unless all terms and conditions of the Sulphur Home Rule Charter are complied with. In accordance with Section 5-04 (E) of the Sulphur Home Rule Charter (Transfer of Appropriations): At any time during the fiscal year the Mayor may transfer part or all of any unencumbered appropriation within programs or functions. Nothing contained in this section shall be construed to prohibit the governing authority from amending or making an appropriation to and for a contingent fund to be used in cases of emergency.

MAY 13, 2019, WHICH SET FORTH SEPTAGE HAULER RATES.

I.

WHEREAS, the CPSO, CITY and POLICE are entering into this agreement for the specific purpose of the CPSO assigning movable property to the CITY and POLICE to be owned, used and maintained by the CITY and POLICE for the purposes consistent with the law enforcement and public safety needs of the whole community.

- 2) The City Council of Sulphur, as governing authority thereof, shall now meet on the 14th day of September, 2020 at 5:30 o'clock p.m., in open and public session at the regular meeting place 500 N Huntington St, Sulphur, LA 70663, Sulphur Louisiana, and will, then and there, examine and canvass the returns and declare the result of said election; and

YOU ARE HEREBY NOTIFIED that on the 10th day of February, 2020, the City Council of Sulphur, Louisiana, acting as the governing authority of the City of Sulphur, Louisiana (the "City"), ordered that a special election be held in the City on Saturday, on the 9th day of May, 2020.

Shall the City of Sulphur be authorized to renew its one-half percent (1/2%) sales and use tax for streets, sewerage disposal, water and waste water systems, and therefore be authorized pursuant to Article 6, Section 29 of the Louisiana Constitution to continue to levy and collect for 10 years beginning April 1, 2021, the existing tax of one-half percent (1/2%) upon the sale at retail, use, lease, or rental, consumption and storage for use or consumption of tangible personal property and on the sales of taxable services, with the collections from the levy estimated to be \$4,100,000 for one entire year, and the avails of the tax after payment for all costs of levy and collection, to be dedicated and used for improving streets, sewerage disposal, water and waste water systems within the City, title to which shall be in the public; and, to issue bonds not to exceed 10 years from the initial levy of the tax, which bonds shall be retired with, paid from, and secured by an irrevocable pledge and dedication of the tax?
