EMERGENCY SHELTER AND STAGING AGREEMENT

The Beauregard Parish School Board will provide temporary shelter and emergency equipment staging area at Singer High School with DeRidder High School as emergency back-up for Hurricane 2020 Season (June 1, 2020 – November 30, 2020), for the City of Sulphur, Louisiana.

Terms and Conditions:


