The next item on the agenda is a resolution amending Article IV, Part 2, Section 9 of the Land Use Ordinance to provide for (9) Political Signs and renumbering existing item (9). Mr. Darby asked how the politicians will find out about this new ordinance. Mr.

Bruce stated that this just isn't for local politicians it's also for all politicians state-wide. How do we notify politicians that don't live here? Mr. Lawrence stated that maybe a certified resolution could be sent to the State. Mr. Darby also stated that he doesn't feel that six weeks is a long enough time frame to get signs out.

Mr. Dorman asked who would validate the signs being picked up. Mr. Bruce stated that Ordinance Enforcement already has a mechanism in place for signs.

At this time Mike Koonce addressed the Commission and asked if he could put a political sign in his yard at any time. Mr. Darby stated, not according to this resolution. Mr. Koonce asked the Commission to look at other municipalities to see how their ordinance reads because he doesn't feel comfortable with this resolution. After discussion, motion was made by Mr. Lawrence seconded by Mr. Dorman that the following resolution be adopted to-wit:

RESOLUTION

Resolution amending Article IV, Part 2, Section 9 of the Land Use Ordinance to provide for (9) Political Signs and renumbering existing item (9).

BE IT RESOLVED by the Land Use Commission of the City of Sulphur, Louisiana, that they do hereby amend Article IV, Part 2, Section 9 of the Land Use Ordinance to provide for (9) <u>Political Signs</u> and renumbering existing item (9) to (10) so as to read as follows:

(9) Political Signs

- (a) All political signs displayed on utility poles, city owned neutral grounds or Right-of-ways are subject to immediate removal.
- (b) A refundable fee of \$100.00 shall be paid to the City of Sulphur prior to the display of political signs within the city limits. This fee may be refunded after the election, if and only if all signage associated with the candidates campaign are removed from all areas of the city within the time limit set out in paragraph (c).

- (c) Political signs shall only be displayed commencing on the official qualification date of the candidate as designated by the Office of the Clerk of Court in and for the Parish of Calcasieu, State of Louisiana and shall be removed within ten (10) days after the election date.
- (d) Political signs shall not be displayed on public property, with the exception of standing billboards.
- (e) Political signs shall be displayed outside the sight triangle as defined in Article IV, Part 2, Section 2 (2).
- (f) Political signs in a Residential District shall not exceed an area of eight square feet.
- (g) Political signs in a Business, Commercial or Industrial District, with the exception of standing billboards, shall not exceed an area of 32 square feet.

(10) Exemptions

All City and/or State regulatory signs and devices, including but not limited to, traffic lights, stop signs, yield signs, and any and all traffic regulatory signs are exempt from this article.

The next item on the agenda is a resolution amending Article IV, Part 2, Section 9

(7) of the Land Use Ordinance – Permitted Portable Signs. After much discussion,
motion was made by Mr. Darby seconded by Mr. Lawrence that the following resolution
be adopted to-wit:

RESOLUTION

Resolution amending Article IV, Part 2, Section 9 (7) of the Land Use Ordinance - Permitted Portable Signs.

BE IT RESOLVED by the Land Use Commission of the City of Sulphur, Louisiana, that they do hereby amend Article IV, Part 2, Section 9 (7) of the Land Use Ordinance to read as follows:

(7) Permitted Portable Signs

Portable, changeable copy signs shall not be permitted in any land use classification within the City of Sulphur except under the following conditions:

- (a) The sign is non-illuminated and non-flashing;
- (b) In the event that the sign is electrically wired, the wiring must be hardwired such that the wiring is totally encased in a durable conduit and located such that it is not subject to crossing by vehicular or pedestrian traffic;
- (c) The sign replacement adheres to all setback requirements and imposes no hazard to vehicular or pedestrian safety and further provides no deterrent to health, safety and welfare of the general citizenry;
- (d) The sign is officially permitted and authorized by the Building Official in and for the City of Sulphur;
- (e) The sign is out of any visibility triangle at intersecting corridors;
- (f) The sign is securely fastened to the ground to avoid the sign from being easily removed, overturned or relocated.
- (g) The sign is compatible with the district land use restrictions set out in the Land Use Ordinance. (See IV.2.9.4)
