WHEREAS, the City of Sulphur, Louisiana, as a participant in the Authority must approve the Authority's projects and financings;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sulphur, Louisiana (the "City Council"), as follows:

<u>SECTION 1.</u> The statements of fact expressly contained within the preamble to this Resolution have been specifically reviewed by the City Council and are found to be factually true and correct, and are made resolutions of the City Council.

<u>SECTION 2.</u> There being a real public necessity for the issuance of the Bonds by the Authority, authorization and approval of the issuance of the Bonds is hereby given to the Authority for the issuance, sale and delivery of the Bonds to advance refund and/or defease the Authority's Outstanding Bonds, subject to the approval of the Louisiana State Bond Commission.

SECTION 3. The Mayor, the Chairman and/or the Clerk of the Council of the City of Sulphur, Louisiana, are hereby directed to execute, deliver and take all action necessary or desirable in conformity with the Act for carrying out, giving effect to and consummating the transactions contemplated by the Bonds, this Resolution, any offering memorandum, the Bond Purchase Agreement and/or the Bond Placement Agreement, and all other documents, instruments or certificates necessary or proper for the issuance, sale and delivery of the Bonds, including without limitation, execution and delivery of any closing documents in connection with issuance of the Bonds.

<u>SECTION 4.</u> It is the express purpose and intention of this entity by the adoption of this resolution to award and deliver to the Authority all necessary and proper authority and discretion to accomplish and complete the issuance, sale and delivery of the Bonds.

<u>SECTION 5.</u> All other resolutions in conflict herewith be, to the extent of such conflict, and the same are hereby repealed.
