It's so tall it may fall across the street and fall on their house.

Mrs. Ellender stated that they're trying to clean up the city. That's why they have the age of mobile homes. Mrs. Landry stated that she scrubbed the exterior of the mobile home and crawled underneath the mobile home and stapled underneath it. Her car is broke and trying to find a job.

Jonathan Thibodeaux, East Carlton, stated that this is not a pretty neighborhood. Mrs. Landry has been warned 2-3 times about the condition of her property. He doesn't feel this is the right location for this mobile home.

Bill LeBlanc, Roberta Drive, stated that he doesn't know Mrs. Landry's situation but until the Council finds out more about what's going on in her life maybe they should postpone this variance.

Mrs. Abshire stated that it's not easy making decisions like this. She's sure there's history with her landlord and the condition of her property. She drove by two weeks ago and it looked a mess. Mrs. Abshire told Mr. LeBlanc that he's always asking the Council to bring the standards up for north Sulphur.
