The Land Use Commission of the City of Sulphur, Louisiana, met in regular session at its regular meeting place located at 500 North Huntington Street, Sulphur, Louisiana, at 5:30 p.m., on the 20th day of September, 2010, after full compliance with the convening of said meeting, with the following members present:

LENORE CARROLL, Land Use Commission District 1 TROY DARBY, Land Use Commission of District 2 JOHNNY PEEL, Land Use Commission of District 3 LAWRENCE DAVID, Land Use Commission of District 4 GERRIT LAWRENCE, Land Use Commission of District 5

After the meeting was called to order and the roll called with the above results, prayer was led by Mr. Peel followed by the reciting of the Pledge of Allegiance led by Mr. Lawrence.

The Chairman asked if there were any changes to the minutes of the previous meeting. With no changes being made, motion was made by Mr. David seconded by Mr. Peel that the minutes stand as written. Motion carried.

The Chairman asked if there were any changes to the agenda. Motion was made by Mr. David seconded by Mrs. Carroll that the agenda stand as written. Motion carried.

The first item on the agenda is a resolution granting a variance to Article IV, Part 3, Section 2 (1) (a) of the Land Use ordinance to allow Donna Little, 613 North Irwin Street, to live in an RV. Mrs. Little addressed the Commission and stated that she has health issues. She then presented a letter from her doctor, as well as a petition from her neighbors. Mr. David asked Mr. Bruce what kind of medical records do administration request from an applicant. Mr. Bruce stated that it should include the nature of the illness and what kind of care they would need.

Mr. Holloway, neighbor, stated that they have been trying to get rid of travel trailers in their neighborhood for some time.

Mr. Bruce stated that Mrs. Little is asking for her travel trailer to be a permanent dwelling. When the City grants variances for travel trailers to be used as a dwelling it's usually on a temporary basis, not permanent.

Mr. Darby stated that this variance is not in the City's long-range plan. This defeats all the purpose of the plan.

Ms. Turner, neighbor, addressed the Commission and stated that Mrs. Little keeps her yard in immaculate condition and she has enough room for the travel trailer. Other streets in this neighborhood have boats, cars, etc. all in their yards. She even has enough parking for at least 4 vehicles.

Michelle, Mrs. Little's daughter, addressed the Council and stated that her mom needs her freedom and doesn't want to live with her. She wants her mom to be close to her. She is not putting her mother in a nursing home.

Mr. Peel stated that the City just got rid of most of the FEMA trailers and we don't want to go back to that same situation.

Mr. Bruce stated that the property doesn't meet the 6,000 sq. ft. requirement for two dwellings and an RV (travel trailer) is not recognized as a dwelling unit in the City of Sulphur unless it's in an RV park.

Randy Hebert, Live Oak, asked the Commission to table this resolution for 6 months until she could find a place to live.

Mr. Darby stated that she would have to reapply for a temporary variance because this variance was for permanent residence.

Mr. Darby suggested that this item be tabled because if they vote against it and

the City Council votes against it then she will have to wait 1 year before she can fill out

another application for this variance. This travel trailer doesn't even meet the 600 sq. ft.

requirement for a dwelling unit.

Mr. Bruce suggested to Mrs. Little that she call the Council Clerk and set up an

appointment to meet with administration to discuss other options.

After discussion, motion was made by Mr. Peel seconded by Mr. David that the

following resolution be tabled:
