City shall have the right to remove any structure or improvement which encroaches within these limits. Cost of restoration or replacement of that structure shall be borne by the property owner. City shall not be liable for damages associated with removing or relocating said structure.
- B. In the event of a violation of Section A, above, notice shall be given to the owner of the lot, place, or area where the violation exists, as shown on the last assessment roll of the City, which notice shall be given by registered mail, addressed in accordance with the tax rolls of the City.

- C. If no action has been taken by the owner of the property within ten (10) days after notice has been given as above provided, or the registered mail is returned to the City with no forwarding address, then the Mayor shall employ the necessary labor and proceed to perform the necessary work for the removal of any structure or improvement which violates Section A.
- D. If, after the removal of any structure or improvement, by the City after due notice as above provided, the costs or expense thereof has not been paid within ten (10) days, the tax collector of the City shall furnish the owner, as shown on the last assessment rolls of the City, by registered mail, a written statement showing the cost or expense incurred for the work. If the statement is not paid within one (1) month thereafter, the amount thereof shall be included in and shall form part of the taxes due by the owner of the property, and when collected shall be credited to the general fund of the City.
