January 14, 2013

The City Council of the City of Sulphur, Louisiana, met in regular session at its regular meeting place in the Council Chambers, Sulphur, Louisiana, on January 14, 2013 at 5:30 p.m., after full compliance with the convening of said meeting with the following members present:

DRU ELLENDER, Council Representative of District 1 VERONICA ALLISON, Council Representative of District 3 RANDY FAVRE, Council Representative of District 4 STUART MOSS, Council Representative of District 5

ABSENT: MIKE KOONCE, Council Representative of District 2 (sick)

After the meeting was called to order and the roll called with the above result, prayer was led by Doug Cain, Henning Memorial United Methodist Church, followed by the reciting of the Pledge of Allegiance led by Mr. Moss.

The Chairman asked if there were any changes to the minutes of the previous meeting. With no changes made, motion was made by Mr. Favre seconded by Mr. Moss that the minutes stand as written. Motion carried.

The Chairman then asked if there were any changes to the agenda. Motion was made by Mr. Moss seconded by Mr. Favre that the following amendment be made:

The next item on the agenda is Rule to Show Cause for the condition of the following addresses:

To condemn building or structure located at 387 North Post Oak Road, in accordance with Article IX, Section 5-286 through 5-296. Mrs. VanderHey addressed the Council and stated that this structure is unoccupied and it has broken windows and it's not tied down.

Dennis Sumpter, representative for Double B Properties (owner of trailer park), addressed the Council and stated that the procedure that the City has followed for this Rule to Show Cause was done improper and they did not follow their own ordinance. The ordinance requires, as does the U.S. Supreme Court, that the owner of the trailer and the owner of the immovable property must be served. The owners of the trailers for this address and the next one on the agenda (401 North Post Oak) have never been served. The notice that Double B Properties received falls short of why the notice was sent (i.e. window broken, etc.). He also stated that Mennonites vs. Board of Commissioners in the U.S. Supreme Court states that "any failure by any governing body to affect the ownership rights or financial position is totally void unless anyone that has a financial interest in it is

notified" (i.e. mortgage company, land owner and trailer owner). These owners weren't notified accordingly. Mr. Sumpter also stated that he does own the property but doesn't own the trailers and the owners of the trailers have not been notified properly.

Mitch Redd, City Attorney, stated that in 2012 the Council adopted an ordinance that basically states that when the owner of a structure is not known then notice to the landowner should be sufficient. Mr. Sumpter stated that this isn't in-line with Mennonites. He asked that this be tabled until all parties can be notified.

Mrs. Ellender asked if our ordinance says otherwise, does the Mennonite law have to followed? Mr. Redd stated, yes it does. He also stated that when we can't find the person that owns a trailer we made a provision that the owner of the property be notified. There should have been a form that Double B Properties received that said if you are not the property owner we need you to let the City know who it is so we can notify them, otherwise we just don't know. Mr. Sumpter stated that to his knowledge the City was notified of the correct property owner of the trailer but that owner has never been notified.

At this time Mrs. VanderHey, Ordinance Enforcement, stated that the form was sent to Double B Properties asking for ownership of these two properties but was never sent back to her (for 387 North Post Oak and 401 North Post Oak). Mrs. Ellender asked Mr. Sumpter why the form wasn't filled out by Double B Properties. Mr. Sumpter stated that it wasn't his responsibility, it's the City's. The law of the land states that if you are affecting ownership rights the City has to notify the owner and everyone involved, even the mortgage company. U.S. Supreme Court turned this case over and said even if you advertise in the newspaper that isn't the correct way to do it. You must notify that owner, you can't rely on someone else to notify the owner.

Mr. Sumpter also stated that even though Double B Properties did not fill out the form stating who the property owner of the trailer was, Double B Properties called City Hall several times and personally gave the name of the owner.

Mr. Favre asked how much due diligence does Ordinance Enforcement go through until we reach a point of no return? This could go on forever trying to locate the owner. The City asked Double B Properties to help find these owners and they refused. The City can't keep going on and on trying to locate these owners. Mr. Redd stated that 5-287 in the Code of Ordinances addresses this issue when the City can't find the owner of the trailer we ask for assistance from the immovable property owner. The City has complied with their ordinance, whether or not it complies with Mennonites that's what we have attempted to do.

Mrs. Ellender asked Mr. Sumpter if he wants these trailers demolished or is he fighting for them not to be demolished. Mr. Sumpter stated that there is a mortgage on all this property which will then put a lien on the property. The mortgage company hasn't had a chance to defend themselves either. He also stated that he would guarantee that if Council rules to demolish this property it would be overruled because of the mortgage.

Mayor Duncan then asked Mr. Sumpter if there was a reason why he didn't fill out the form and send it back to City Hall. Double B Properties has no obligation to send it back. The Police Department has records on one of the owners. Mayor Duncan then asked if any of the owners knew about this meeting. Mr. Sumpter stated that one of them was in attendance but didn't get notified.

Doris Meaux addressed the Council and stated that she does own 401 Post Oak. She currently lives at 2511 Jett Street. She did give the City of Sulphur her name and address

when the trailer was busted. Every month for four months she calls the City of Sulphur to find out when the meetings are held. That's why she's always at the meetings. She also stated that she has given Mrs. VanderHey her name and address. Mrs. VanderHey stated that she was never given the owners name and address. Mrs. Meaux stated that since this has happened a certain person is out of jail because he wasn't convicted of operating a meth lab. In the mean time they let the trailer be shut down for the summer. She called Baton Rouge, New Orleans, the Sheriff's lab in Lake Charles and someone in Sulphur trying to get them to do a meth test and no one will come. They won't come do the test because it wasn't a meth lab conviction.

Mr. Redd stated that when Council amended the ordinance to take extra steps to notify owners they did it for the importance of the property rights and if that's something the Council wants to be consistent with then his advice would be not to take action on these two items tonight. Make sure Shelly has Ms. Meaux's address so she can be contacted. His recommendation would be to table this item and the next item on the agenda until owners are notified.

Mr. Sumpter stated that he would help Mr. Redd in notifying the owners of the trailers to the best of his ability. Doris Meaux is owner of 401 Post Oak and Lawrence Brown is owner of 387 Post Oak. He doesn't have Mr. Brown's address.

Motion was then made by Mr. Favre seconded by Mrs. Ellender to table this Rule to Show Cause located at 387 North Post Oak Road until the next City Council meeting (Monday, February 11, 2013).

Mrs. VanderHey stated that Mr. Holly received his first notice of this meeting on December 3<sup>rd</sup> by the Marshal. Mayor Duncan asked Mr. Holly since he purchased his permit back in March 2012, what work has been done to the home. Mr. Holly stated that all the material that was burned has been removed. There was no structural damage, just cosmetic. Mr. Holly stated that he is trying to find the person that set the house on fire. Mrs. Allison stated that he does not have to wait to find the person that burned his home before starting the repairs.

Keith Berry, Building Official, addressed the Council and stated that the room of origin has about a 10' hole, there's no ceiling, roof damage; it's an easy repair. He has given Mr. Holly a permit to repair but nothing has been done. Mr. Holly can take the boards down while making repairs but then put them back up when he's done for the day.

Mayor Duncan stated that on February 11, 2012 a stop work order was issued. Can a timeframe be given and if that timeframe isn't met then it gets demolished. Mr. Holly will give the City a timeframe and he will have to follow it.

Mr. Berry then stated that the Council can issue a Rule to Show Cause and if Mr. Holly doesn't follow the timeframe in the next 30 days then the house will be demolished. Danny Dupre, Fire Chief, stated that this house has been a major concern in this neighborhood. Mr. Holly has made many, many promises for many years and he needs to take care of his business. Motion was then made by Mrs. Ellender seconded by Mr. Favre that 321 Starlin Street be demolished.
