Common Core and the oil and gas issue was the biggest topic. They balanced the budget with some contingencies. They also passed the Land Use Commission bill. Mr. Johns stated that what's killed in session is almost more important than what is passed. He sits on the Finance Committee and they had to balance the budget. It is a \$24.6 billion budget. There were two bills that caught his eye (1) was the closing of the DMV and (2) the hours for the Cameron ferry. Luckily there will be no changes to these two bills. One other issue was the capital outlay money for the North Industrial railroad spur. There was \$2.2 million for that project that hadn't been used in years. The State is starting to resend project money if it hadn't been used. There are other projects on hold that could use this available money. That money will now be used for sewer pump station.
