ORDINANCE SUBDIVIDING LOTS AND ACCEPTING FINAL PLAT FROM
CKV INVESTMENTS FOR PROPERTY LOCATED ON WEST SIDE OF

WHEREAS, final plat has been submitted by CKV Investments to subdivide property into 3 conforming lots on the west side of Hoffpauir Road; and

ORDINANCE ADOPTING THE FIRE MAINTENANCE AND STREET
MAINTENANCE MILLAGE RATES IN THE CITY OF SULPHUR,

BE IT ORDAINED by the City Council of the City of Sulphur, Louisiana, the governing authority thereof, that the following millages are hereby levied on the 2015 tax roll on Fire Maintenance and Street Maintenance property subject to taxation by the City of Sulphur:

The next item on the agenda is a public hearing on ordinance adopting the annual budget of revenues and expenditures for the fiscal year July 1, 2015 to June 30, 2016, for the City of Sulphur, Louisiana. Mr. Moss asked why Tourism went from \$47,000 last year to \$150,000 this year in the Mayor's budget. Mayor stated that there were some big things coming up this year. We still have 3 months for 2014-2015 budget so we will spend more than \$47,000. Motion was made by Mr. Moss seconded by Mr. Favre that the following amendment be made:

- Decrease Tourism from \$150,000 to \$100,000.

Motion carried.

Mr. Bergeron stated that he had concerns with the new position for Planning Coordinator/Assistant Land Use Administrator. He stated that under the Director of Public Works there is now a Superintendent that runs the maintenance department. This was to take the load off the Director of Public Works so he could handle more of the subdivisions, land use, annexations, etc. In the description of the DPW he is the Land Use Administrator so he's supposed to meet with developers, fill out applications, answer phone calls, etc. When the Director of Public Works left, Arlene had more knowledge of Land Use so she started doing all this. Now that we have another Director all this should go back to the Director. He doesn't understand why we need to hire a Planner at \$50,000 a year when we have someone that should be doing this job. Mayor Duncan stated that there's more to it than just that. With the growth and expansion that's here now we need to respond to people in a timely manner and this new position would help out across the board. It's not just for Land Use. Things that normally take 10 days to do now take 30-45 days to do. Cities our size have Planners. We asked the Council a while back if they would be in support of a Planner and everyone agreed. Mr. Bergeron stated that he didn't agree to that. Mrs. Ellender stated that the Council didn't agree to a Planner we said we would listen to what administration had to say about hiring a Planner. Mr. Bergeron stated that the

Council needs a more detailed job description of what this new person would be doing. If the Director of Public Works isn't going to do Land Use then tell us what exactly he will be doing. Mr. Bergeron also stated that when he was Director of Public Works/Land Use Administrator he meet with all the developers, filled out the zoning signs, answered the phone calls and accepted the applications. That was my job. Mayor Duncan stated that Michael (DPW) is very busy with water, sewer and roads. He's one of the very few Public Works Directors that goes to every job site. Mr. Bergeron said to come back with a full job description and he may entertain it.

Mrs. Allison stated that Council can put it in the budget and once we get the job description and we don't feel this position is necessary we don't have to hire for this position. Mayor Duncan stated that Council will receive the job description and if Council doesn't feel this position is needed then we won't do it. Mr. Moss asked who will be the supervisor of this new person. Mayor Duncan stated that Administration will make that decision.

Mr. Favre stated that the Public Relations/Marketing position is very much needed. The salary will be \$25,000 a year and this is something the City needs.

Another concern Mr. Moss had was the training academy for the fire department. Chief Dupre stated that the earliest Lake Charles is having their academy is August and he just doesn't think they can wait that long. Mr. Moss stated that since we are understaffed and trying to get training for the fire department and police department he would like to take \$10,000 out of the \$50,000 that was cut from tourism and divide it in half for the fire and police department for training. Motion was then made by Mr. Moss seconded by Mr. Favre that the following amendment be made:

- Increase \$5,000 for Police Department training
- Increase \$5,000 for Fire Department training

Motion carried.

Motion was then made by Mr. Moss seconded by Mr. Favre that the following ordinance be adopted to-wit:

ORDINANCE NO. 1296, M-C SERIES AS AMENDED

AN ORDINANCE ADOPTING THE ANNUAL BUDGET OF REVENUES AND EXPENDITURES FOR THE FISCAL YEAR JULY 1, 2015 TO JUNE 30, 2016, FOR THE CITY OF SULPHUR, LOUISIANA.

BE IT HEREBY ORDAINED by the City Council, City of Sulphur, Louisiana, in general session convened, that:

- SECTION I. The attached estimate of revenues as reflected in the summary and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Government Act, be and the same, is hereby adopted to serve as the Budget of Revenues for the City of Sulphur for fiscal year July 1, 2015, to June 30, 2016.
- SECTION II. The attached statement of anticipated expenditures as reflected in the summary and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Government Act, be and the same is hereby adopted to serve as the Budget of Expenditures for the City of Sulphur for the fiscal year July 1, 2015, to June 30, 2016.
- SECTION III. The adoption of the Budget of Expenditures as reflected in the line-item budget filed with the Clerk of the Council containing object of expenditure classifications shall be declared to be the appropriation of the amount set therein as established in each budget classification by object of expenditure.
- SECTION IV. The adoption of the Capital Improvement Budget as submitted for a period of five years with the first year being for the budget year 2015-2016 shall be for the expenditures as appropriated therein.
- SECTION V. The amounts appropriated for all accounts shall not exceed the amounts fixed therefor in the Budget of Expenditures unless all terms and conditions of the Sulphur Home Rule Charter are complied with. In accordance with Section 5-04 (E) of the Sulphur Home Rule Charter (Transfer of Appropriations): At any time during the fiscal year the mayor may transfer part or all of any unencumbered appropriation within programs or functions. Nothing contained in this section shall be construed to prohibit the governing authority from amending or making an appropriation to and for a contingent fund to be used in cases of emergency.

BE IT FURTHER ORDAINED that this Ordinance shall become effective ten (10) days after publication.
