La State Contractor's License and proof of State of Louisiana workman's comp coverage is required according to type and cost of job

- Commercial jobs that exceed \$50,000.00 must have State Contractor License.
- Residential jobs that exceed \$7,500.00 must have State Home Improvement License.
- Residential jobs that exceed \$75,000.00 must have State Contractor License.
- All Electrical Contractors must have a Louisiana Master Electrician License.
- All Mechanical Contractors must have a Louisiana Mechanical License.
- All Plumbing Contractors must have a Louisiana Plumbing License.

La. State Master Electrician, Mechanical, or Plumber's License \$15,000 Surety Bond in favor of the City of Sulphur \$100,000 minimum Control Liability Ingurance Continues for the

\$100,000 minimum General Liability Insurance Certificate for the City of Sulphur

- Current year Occupational License from location where business is located

 If municipality or parish does not issue licensing, or if a Non-Resident Contractor of Louisiana, a license must be purchased with the City of Sulphur based upon the cost of the job. Any electrician, mechanical contractor or plumber must also be licensed with the City of Sulphur regardless of business location.
- Calcasieu Parish Non-Resident Contractor Compliance Certificate

 This is required for contractors performing a job that is \$3000 or more and who do not have a business location within the State of Louisiana. CALCASIEU PARISH TAX OFFICE-337-217-4280
- Certificate of Authority to do Business in Louisiana (For Non-Resident Contractors)
 This is required from the Secretary of State for non-Louisiana corporations 225-925-4704
- Louisiana State Letter of Good Standing
 This is required for contractors performing a job that is \$3000 or more and who do not have a business location within the State of Louisiana. STATE TAX OFFICE- 855-307-3893
