Southgate Street, located 175 feet east of the east right of way line of Ruth Street. The locations of said right of way lines shall be as defined as of the date of this rezone.

- 1. Provide a buffer strip twenty-five feet in width, along the full length of the parcel's east property line.
- 2. Permissible uses do not include casinos or bars.
