The City Council of the City of Sulphur, Louisiana, met in special session at its regular meeting place in the Council Chambers, Sulphur, Louisiana, on December 21, 2021, at 5:30 p.m., after full compliance with the convening of said meeting with the following members present:

After the meeting was called to order and the roll called with the above result, prayer was led by Mrs. Ellender, followed by the reciting of the Pledge of Allegiance led by Mr. Koonce.

The first item on the agenda is condemnation of structures in accordance with Chapter 5, Section 289 of the Code of Ordinances of the City of Sulphur for the condition of the following addresses:

- a. To condemn building or structure located at 703 North Huntington Street.
- b. To condemn building or structure located at 1214 Tillman Street.
- c. To condemn building or structure located at 1512 South Scott Drive.
- d. To condemn building or structure located at 751 South Crocker Street.
- e. To condemn building or structure located at 616 Cass Street.
- f. To condemn building or structure located at 1608 Weekly Road.
- g. To condemn building or structure located at 1208 South Crocker Street.

- h. To condemn building or structure located at 607 East Thomas Street.
- i. To condemn building or structure located at 216 Vine Street.
- j. To condemn building or structure located at 1284 South Post Oak Road.
- k. To condemn building or structure located at 797 North Claiborne Street.
- l. To condemn building or structure located at 411 Foreman Avenue.
- m. To condemn building or structure located at 919 Lewis Street.
- n. To condemn building or structure located at 110 South Marauder Street.

Mrs. VanderHey, Ordinance Enforcement Officer, stated that the homeowners signed voluntarily and notices have been posted. This is the first batch and there are more to come. These condemnations will be at no cost to the City nor the homeowner. Motion was made by Mrs. Ellender seconded by Mr. Koonce that the above addresses be condemned.

The next item on the agenda is an introduction of ordinance authorizing Mayor Mike Danahay to enter into a Cooperative Endeavor Agreement with multiple entities for the SWLA Sexual Assault Nurse Examiner (S.A.N.E.) Program. Motion was made by Mrs. Ellender seconded by Mr. Koonce that the following ordinance be introduced:
