At this time George Swift, Economic Development Alliance, addressed the Board and stated that the Alliance has a catalog with available buildings for company's looking to come to this area. These companies usually have special requirements (i.e. railroad spur connection, I-10 corridor, etc.). There are very few sites in this area that meet requirements they request. The average request for proposal is 177,000 sq. ft. Usually the Alliance can't meet the request for a building but if they are looking for property we can help them more with that. Mr. Swift also stated that someone from the Industrial Board needs to act as liaison to the Alliance. Mr. Hamilton stated that he felt that the President should act as liaison. Mr. Hardy stated that he would like to act as liaison. Mr. Swift also stated that surrounding entities help fund the Alliance. The City of Sulpur donates \$7,000 each year. These funds help market programs.

At this time Mr. Hamilton stated that after 18 years of serving on the Industrial Board he would be resigning. He also stated that since this was a whole new Board he suggested at their next meeting they have Jay Delafield and Vernon Meyer come and speak to them.

There being no further business to come before the Board, the President declared the meeting adjourned.
