The only item on the agenda is to consider and take appropriate action on resolution concerning proposed Home Rule Charter. Cade Cole, City Attorney, stated that clarification needed to be made so there's no confusion. The amendment in question is to delete the word "registered" from Section 8-11. State statute has it written correct, but we just need to mirror state statue without the word "registered" so there's no confusion. Motion was then made by Mr. Rosteet seconded by Mrs. Granger that the following resolution be adopted towit:

## RESOLUTION PROPOSING REVISED AND RESTATED HOME RULE CHARTER FOR THE CITY OF SULPHUR

WHEREAS, the City Council as governing authority of the City of Sulphur acting pursuant to Section 7-06(E) of the Home Rule Charter of the City of Sulphur and La. R.S. 33:1395-1 did adopt Ordinance No. 1811, M-C Series duly appointing seven citizens to serve as the Home Rule Charter Commission to modernize, update, and improve the Home Rule Charter of the City of Sulphur.

WHEREAS, the citizen members of the Home Rule Charter Commission of the City of Sulphur have met over the past four months to discuss how to modernize, update, and improve the Home Rule Charter of the

City of Sulphur, received comment from interested members of the public, and held a public hearing on the final proposal that was previously published for review;

WHEREAS, on March 27, 2023, the Home Rule Charter Commission for the City of Sulphur formally proposed that a revised and restated Home Rule Charter and call for the City Council to call an election at the earliest opportunity provided for under the laws of Louisiana for ratification of this proposed Home Rule Charter.

WHEREAS, after submission the Charter Commission discovered a typographical error that does not comport with R.S. 33:1395.3 requiring a vote by a majority of those voting in the election.

THEREFORE, BE IT RESOLVED by the Home Rule Charter Commission for the City of Sulphur that it does hereby formally revise its prior proposal only to remove the word "registered" from Sect. 8-11 and otherwise ratifies and affirms its proposal of the attached revised and restated Home Rule Charter and call for the City Council to call an election at the earliest opportunity provided for under the laws of Louisiana for ratification of this proposed Home Rule Charter such that it shall be effective upon a majority vote of those voting in the election called on its ratification.

A vote was then called with the results as follows:
